Brief Statement of Accident: UNIT#1 (DARK GRAY DODGE RAM JBC1837 - OH) WAS HEADED NORTHBOUND ON N DETROIT AVE APPROACHING MONROE ST IN THE PASSING LANE WITH A GREEN LIGHT AND THE RIGHT OF WAY. UNIT#2 (UNKNOWN PEDESTRIAN) WAS HEADED WESTBOUND IN THE DRIVEWAY OF THE GAS STATION ON THE SOUTH SIDE OF MONROE ST APPROACHING N DETROIT AVE, WITH A "DON'T WALK" SYMBOL FOR THE CROSSWALK NEARBY. THE PEDESTRIAN WALKED OUT INTO THE ROADWAY FROM THE DRIVEWAY AND WAS STRUCK BY UNIT#1'S PASSENGER SIDE MIRROR AS IT MOVED FORWARD TOWARDS THE INTERSECTION CAUSING AN ACCIDENT. WITNESSES ON SCENE VERIFIED WHAT HAD OCCURRED. THE PEDESTRIAN WAS INJURED, WAS TREATED ON SCENE BY TOLEDO FIRE, AND WAS TRANSPORTED TO TOLEDO HOSPITAL FOR TREATMENT. THE PEDESTRIAN ATTEMPTED TO REFUSE TREATMENT FROM FIRE PERSONNEL, BUT WHEN SHE ARRIVED AT THE HOSPITAL, SHE DEVELOPED MORE SERIOUS HEAD INJURY SYMPTOMS. THE PEDESTRIAN HAD NO IDENTIFICATION AND REFUSED TO PROVIDE HER INFORMATION TO POLICE OR FIRE PERSONNEL WHEN SHE WAS CONSCIOUS. THE INVESTIGATION CONTINUES.
