Brief Statement of Accident: Unit 2 was WB on W Laskey and crossed the center line in the 1200 block, striking Unit 1 head-on, which was EB on W Laskey. Driver of Unit 2, Billy Fell, was transported to Toledo Hospital and pronounced deceased. Passenger of Unit 2, Deshawn Joyce, was transported to Toledo Hospital with life threatening injuries. Driver of Unit 1, Austin Ellis, was transported to St V's with non-life threatening injuries. Passenger of Unit 1, Jonathon Hargrove, was transported to Toledo Hospital with possible serious injuries.
